- Maintain a constant dialogue with the relevant authorities of the participating countries;
- Bring its own expertise in all aspects of the implementation of the activities of his/her component;
- In according with the DD Identify and mobilize specific expertise from different EU and AL countries;
- Work closely with the Senior Project Officers and the Project Management Units a of the other components, in order to ensure a complementarity between their respective activities, develop common activities and share good practices;
